NATIONAL LEAGUE (NL): Managers of an NL baseball team must complete the information below and return it to their respective Commissioner, along with certificate of completion of the USA Baseball Coaches Certification Program (see below), no later than the deadline listed above. For certain NL divisions, managers must protect a minimum of 9 players and a maximum of 10 players (7/8U, 9/10U, 11/12U, 13/14U). 6U NL must protect a minimum of 4 players and a maximum of 6 players.

AMERICAN LEAGUE (AL): Managers wanting to manage an AL team must submit this form to their respective Commissioner, along with certificate of completion of the USA Baseball Coaches Certification Program (see below), no later than the deadline listed above. For certain AL divisions, managers may protect 6 players (7/8U, 9/10U, 11/12U). 6U AL may protect up to 4 players.

ALL protects MUST be listed below and signed by the players' parents (including children of the manager). Parents understand that by signing this form their child is committed to playing for this manager for the season listed above. NL can host up to 70% of the teams, AL hosts the remainder (30% or more). In the event that there are not enough teams to form two divisions then teams will follow NL protect rules.
